Junior Swine Rules

Swine Show March 2, 2024

1. Showmanship –Students will show by grade as of what grade they are in the day of the show.
Class 1- 2nd grade and under Novice Division
Class 2-3rd-6th grade Junior Division
Class 3-7th-10th grade Intermediate Division
Class 4-11th grade-21 years of age Senior Division
(If classes are too big, we will break into heats, but only place 10
Hogs will be weighed when they arrive at the show and placed in a weight division. We will show in Light Weight, Medium Weight, and Heavy Weight classes.
Premiums are based each year on sponsorships and will be given based on the amount raised.
2. Pens will be available
3. The show will be held outside in panels under a tent-Bring chairs!
4. Pigs must be clean and ready to show, no wash area available
5. The judges' decision is final in all classes.
6. No abusive behavior towards animal or person will be tolerated. Any parent or exhibitor found in violation will be asked to leave the show grounds immediately.
7. All animals must be in good health
8. No power will be available. Bring a generator if needed.
9. Food Vendors will be on site
10. No dogs allowed!
11. Please follow the CDC guidelines for COVID-19, Flu, and RSV. The health and safety of our exhibitors and their families are of utmost concern.
